#### **FOREWORD**

The tax year-end is often a blur of long working hours and tight deadlines. This guide shows you how using cloud-based software to its full capacity can make tax season more manageable.

Following the holiday season, accountants and bookkeepers are quickly gearing up for the self-assessment filing deadline. Coupled with the annual accounts deadline for most companies, the beginning of the year isn't always smooth sailing.

It's not uncommon for accountants and bookkeepers to work long hours during tax season, and many admit it's their most challenging time. Back in 2022, a study by CABA identified that 55% of accountants suffered from stress and burnout, with 87% citing heavy workloads as the reason. More recently, CABA reported increasing demand for their services as more accounting professionals seek mental health support.

The pressure on accountants will only increase in the coming years. With the first phase of Making Tax Digital (MTD) for Income Tax due to begin in 2026 and software-only filing for Companies House on the horizon, practices might need to rethink their processes and workflows. Thankfully, accountants and bookkeepers now have cloud accounting software and improved automation features at their disposal. Software such as Xero Tax offers an end-to-end accounts production and tax solution. You can easily prepare and file sets of accounts and tax returns using the core data from Xero bookkeeping software. Compliance tasks can be spread across the year and jobs delegated throughout your practice.

## 1. CENTRALISE DATA AND COMPLIANCE TASKS WITH A SINGLE PLATFORM

Many accountants and bookkeepers rely on multiple applications and systems in their practices. This disconnected approach can lead to duplicated tasks – where the same information needs to be typed into multiple systems. And it's much harder to judge the amount of work, how long it takes, and the profitability when platforms aren't connected.

Xero provides an end-to-end solution, meaning you can take care of all tasks in one place – from day-to-day bookkeeping, to HMRC and Companies House submissions.

With Xero in your practice, you can:

- Access bookkeeping, tax, and practice management features in one place
- Automatically populate company accounts and returns using client data from Xero bookkeeping, speeding up account preparation
- File accounts and returns directly from Xero Tax to HMRC and Companies House, without switching between multiple platforms
- Easily make adjustments at the end of a tax filing period with automatic final tax journal calculations posted back to the books
- Send accounts, tax returns, and other documents to clients for signing electronically
- Spread compliance work across the whole practice (and tax year) with customisable access and permissions, and unlimited users available at no extra cost.

Our latest product updates mean you have even more tools to manage practice, staff, client, and compliance work. With the addition of partnership tax coming soon, you can use a single piece of software to file for a wider range of clients.

Where you require extra functionality, Xero has a growing ecosystem of integrated apps that can be tailored to your industry, business function, and users. Hubdoc, for example, allows clients to snap a photo of their bills and receipts, and email them to their Xero organisation. Transaction details are automatically extracted and captured in Xero, so there's no need to type them yourself.

With a suite of features in Xero and added app integrations, you can handle all of your data and tasks in one connected system.

#### 2. ADAPT TO REGULATORY CHANGE

Xero helps you take new legislation in your stride, allowing you to shift seamlessly to new ways of working.

Over the coming years, accountants and bookkeepers will need to adjust to various legislation and industry changes:

- Software-only filing requirements for incorporated businesses are expected in the next few years, as part of Companies House Reform. Already, increased powers for Companies House to query and challenge information on the register have been introduced.
- The SME scheme and RDEC scheme were merged in April 2024. Separately, more R&D-intensive SMEs are likely to be eligible for relief now that the threshold has dropped from 40% to 30%.
- As part of Basis Period Reform unincorporated businesses are now required to report on profits generated in the tax year, instead of using the accounting year basis. Some clients will have chosen to keep their unique accounting date, which means you might need to produce multiple sets of accounts for each client, every year.
- Finally, the first phase of MTD for Income Tax comes into place for sole traders and landlords with turnover above £50,000 in April 2026. Practices and clients will need to familiarise themselves with cloud-based software in 2025, ahead of the start date.

Alongside legislative change, technological advancement will also affect how practices operate in future tax seasons. Take our Al-powered business companion – Just Ask Xero (JAX) – as an example. When available, you or your clients will be able to assign simple tasks to JAX, such as paying a bill or chasing up an invoice, without needing to access Xero software. By taking care of the admin, JAX will enable you to work more closely with clients and deliver high-value human-led services.



In the past, changing regulations could require new software or costly add-ons. Updates to Xero products happen automatically, so you don't need to download or install anything manually. Training the team is faster and easier with a single software package in place, too. You'll be able to onboard new hires and upskill team members in no time.

# 3. STREAMLINE COMPLIANCE PROCESSES FOR A SMOOTH YEAR-END

Brilliant accounting teams are held back when compliance processes are slow, unreliable, and inconsistent. Xero Tax frees up time in your practice by providing you with standardised workflows that simplify regular tasks and maintain accuracy.

- 52% of practices reported time savings on manual tasks
- 44% of practices have more time to spend on billable tasks
- 52% of practices have more time to focus on practice growth

Given the hiring challenges in accounting, modern software can ease the burden on practices by automating repetitive admin and enabling staff to focus on more fulfilling tasks. Munro and Partners is a Surrey-based business established in 2011, specialising in the creative, professional, and software sectors. The business also serves a range of business and individual clients across other industries.

#### Moving personal tax to the cloud

Chesterfield-based sole practitioner Andy Housley comes from a background in IT and formerly had his own printing business.
